### **Article 8 of the Statute**

Current Version

### Art. 8 Admission to Membership

8.1 Admission to membership of ICAR shall require approval by the Board



### **Article 8 of the Statute**

Proposed New Version

### Art. 8 Admission to Membership

- 8.1 Admission to membership of ICAR, with full rights and privileges, shall require approval by the Board and need to be proposed by an existing member of ICAR or the ICAR Secretariat
- 8.2 Admission to membership is open to other organizations supporting ICAR's objectives, and need to be proposed by an existing member of ICAR or the ICAR Secretariat and approved by the Secretariat
