	REL <sub>nationalGE</sub> >= 60% => national BVs used
	$REL_{nationalGE} < 60\% \Rightarrow blending of national BVs and converted BVs \\ based on reliability used. Same for national REL and converted REL.$
	If no national BVs exist => converted BVs used.
